
Education and Training Committee

CPD Seminars

During 2013, 7 seminars have been organised, as follows:



Charges

The cost of laying on this programme averages between \pounds 3,500 and \pounds 4,000 per annum (depending on fees paid to external speakers) which means that our continuing charge of \pounds 30 for members allows us to just about break even, with 120 attendances over the calendar year under review.

Evaluation

Evaluations are generally very positive, with many attendees offering additional critical comment. As to attendance, the evaluation results and the comments tend to indicate that interest is generated by the topic (see for example May and September) rather than pre-knowledge or reputation of the speaker. The Committee has noted that topical updates on core subjects tend to be more popular than one-off talks on - perhaps more specialist – topics; and therefore the programme will be more focussed on core subjects of wide commercial interest, with an attempt being made to be more responsive to recent legislation or case-law.

Better Communication

To achieve this objective, it is essential that members communicate with the committee as to what topics are attractive to them. It is also essential that the committee is representative of a broad interest / skills base, as well as (so far as possible) geographically representative. Steps have been and continue to be taken to refresh and reconstitute the committee; but we would particularly welcome volunteers from some of the more rural areas or outlying towns – their contribution is particularly vital to be able to advise the committee how practitioners in such areas are able to plan and execute their continuing professional development, and how the Society may be able to support them in that.

The future of Continuing Professional Development

Over the last three years, committee members have been involved in the consultations, LETR report papers, and ongoing discussions, and have also followed the course of the SRA deliberations on CPD in implementing the LETR recommendations. The Chair and the Co-ordinator in particular have devoted significant time to the debate concerning these changes.

Members will be aware that compulsory CPD hours are to be phased out, but the obligation regarding continuing professional development remains. The Committee has now "mapped out" a way ahead for TVLS to support CPD amongst the membership locally, and a short presentation will be given on this at the 2014 AGM. This presentation will subsequently be published on the Society's web-site, and we will be seeking members' feed-back on the proposals.

And finally ...

Its over 10 years since I took over the role of Administrator for TVLS, and I have decided it's time I moved on to pastures new - although I don't think retirement is quite the word for what I have in mind - more like lapsing into my second childhood!

I am trying to leave TVLS in a position to take advantage of all the latest in technology to operate efficiently comunicate with everyone in the profession in Tees Valley easily.

The website has been re-vamped, and we now have the members area working ... in most cases! There have been some glitches with the password distribution so if you haven't got yours - email me (or my successor) The email address will remain the same, whoever takes over.

The record keeping has been improved from a database which only I could use (& only because I wrote it!) to one which will be much easier to use. There are still some final tweaks to do, and then the real test will come when the data is imported and everything checked over. I have details of over 850 people and 152 firms on the database so there is a significant risk it will go awry - but fingers crossed it wont be too bad.

One of my regrets is that the number of members I am passing on is significantly lower than I "inherited". In 2004 there were over 300 members, falling to fewer than 170 in 2011. So far this year we are up to 184 (which is more than the whole of last year) so things are improving, albeit slowly. But considering I have a database of over 850 individuals, it's a bit depressing.

But before I go, I would like to thank everyone I have worked with over the last 10 years for putting up with me, and to wish to Society - and indeed, the profession - all the best for the future.
