### Brexit - what it means for the profession

On Thursday, 23 June, the UK took the historic decision to leave the European Union - so what happens now and what does it mean for the legal profession?

To keep you informed and up-to-date, here are some of our key messages and some useful links to recent press releases and Gazette articles.

- Brexit means unprecedented and complex • challenges for UK law - read more here

- The Law Society will work with the solicitor profession, their clients, the public and with government to support a calm transition in the wake of the referendum
- Equally for now there will be no change to people's legal rights or obligations.

### Human rights law and Brexit

- Leaving the EU does not remove the UK's membership of the European Convention of Human Rights (ECHR) nor its obligation to uphold the rights set out in the ECHR. Nor would leaving the EU remove the UK from the jurisdiction of the European Court of Human Rights (ECtHR).
- The Law Society believes that any potential future British Bill of Rights would need to maintain the protection of the human rights enshrined in the Human Rights Act and the ECHR. The UK should remain a fully committed signatory to the ECHR as an important international standard in the sphere of human rights.

However, Sir Paul Jenkins QC, a barrister at Matrix Chambers and former head of the Government Legal Department, told the Gazette that the Brexit vote could 'seriously increase' the chances of the UK opting to leave the ECHR.

### Jurisdiction of choice and Brexit

The law of England and Wales will retain its international commercial appeal and will remain an attractive and stable jurisdiction with a high-quality legal profession, internationally respected courts, and the best law firms in the world that have attracted clients from across the globe for many years.

### Immigration, employment and Brexit

- The right of free movement of people remains in effect following the referendum result.
- For people who have already exercised their right of free movement - UK citizens living in other member states and other EU nationals living in the UK - the long-term situation postwithdrawal is not yet clear.
- Much of UK statutory employment law has its origins in EU legislation. The implementation of EU legislation into domestic law means that employment law obligations and protections would not automatically fall away upon the UK's eventual withdrawal from the EU

## Legal comparison site ready to open with 150 firms on board

A Legal comparison site 'The Law Superstore' will be ready for business from 1 August after securing 150 firms willing to be ranked.

The site breaks down 130 legal services based on criteria selected by users, including quality ratings, services, location, expertise and price.

Firms do not pay to be ranked, but will pay a fee after a potential client has chosen a legal service provider and the agreed fee structure and scope of the work has been confirmed.

The firms taking part were hand-picked because of their progressive approach to providing and marketing legal services.

Practising fee consultation - closes 7 July

Solicitors could pay £30 less for their practising certificate (PC) fee this year. The Law Society of England and Wales and the Solicitors Regulation Authority (SRA) are running a <u>consultation (PDF 407kb)</u> proposing an individual rate of £290 per

solicitor for 2016-17. The deadline to have your say is 7 July 2016.

The proposed reduction in the PC fee is 9 per cent this year. If adopted this will mean that since 2014 it has been reduced by 24 per cent.

## Lasting powers of attorney

Any solicitor intending to give advice about a lasting power of attorney (LPA) or act as an attorney under an LPA must be aware of the provisions in the Mental Capacity Act 2005 (MCA 2005) and the Mental Capacity Act 2005 Code of Practice (Code of Practice). Solicitors should also be familiar with the relevant guidance produced by the Office of the Public Guardian (OPG).

The practice note provides an overview of LPAs and also covers the ongoing arrangements for enduring powers of attorney (EPA). It does not deal with situations with an international element, for example, using an LPA to sell a foreign property, or a non-UK individual who wishes to make an LPA.

### Data protection

Processing personal data is fundamental to the work of a solicitor. The Data Protection Act 1998 (DPA) regulates the processing of information relating to individuals. Solicitors must comply with the DPA. Failure to do so may constitute a criminal offence. The Information Commissioner can, in certain circumstances, also impose financial penalties of up to £500,000.

This practice note sets out how solicitors can comply with the Act.

## DCLG consultation on reform of the compulsory purchase system

The Law Society's Planning and Environmental Law Committee recently responded to a joint Department for Communities and Local Government and HM Treasury consultation on further reforms to the principles of assessing compensation and other technical improvements to compulsory purchase processes.

Government stated that its proposals were 'intended to make the compulsory purchase process clearer, fairer and faster', and has subsequently included compulsory purchase legislation in the 2016 Queen's Speech.
